Re: SB 362 (Becker) Data broker registration: accessible deletion mechanism - Request for Veto

Dear Governor Newsom:

On behalf of the California Retailers Association (CRA), I respectfully request a veto of SB 362 (Becker).

SB 362 would undermine protections for consumers and their privacy. Eliminating personal data means deleting all consumer's data. This legislation does not allow for the balance established just a few years ago with the enactment of the California Consumer Privacy Act, which empowers individuals to control their data by choosing which companies can access their data. Consumers may want the ability to prove their identity to their financial institution, participate in consumer loyalty programs or choose to have local organizations advocate on their behalf regarding important legislation. These are just a few examples of the unintended consequences this legislation could have that would negatively impact Californians. It is unfortunate that the legislature did not allow the time to fully vet this issue by making this a two-year bill, which is what CRA advocated for.

Furthermore, SB 362 would weaken protections against identity theft and inadvertently undermine safeguards against consumer fraud. Many financial institutions and online retailers, for example, rely on data provided by data brokers to verify the identities of their customers, protecting them from fraudulent activities and scammers. Deleting certain personal information, such as past addresses or other historical data, could prevent consumers from accessing their financial accounts.

As currently written, SB 362 is an all-or-nothing proposition for consumers. Wipe all their data or none of their data. As with most things in life, what people want is somewhere in the middle. We want to improve privacy and protections without losing the power to utilize our information in specific ways.

The California Retailers Association is the only statewide trade association representing all segments of the retail industry including general merchandise, department stores, mass merchandisers, on-line marketplaces, restaurants, convenience stores, supermarkets and grocery stores, chain drug, and specialty retail such as auto, vision, jewelry, hardware, and home stores. CRA works on behalf of California's retail industry, which operates over 400,000 retail establishments with a gross domestic product of \$330 billion annually and employs one fourth of California's total employment.

For these reasons, we respectfully request a veto on SB 362 (Becker).

Dear Governor Newsom:

The National Federation of Independent Business (NFIB), which represents 14,000 dues-paying, small business members in California, respectfully requests your veto of SB 362 (Becker), which would severely hamper the ability of small businesses to reach new customers and grow their businesses.

Data broker services are an important tool utilized by small businesses that enable them to attract potential customers by leveraging third-party data sets. This also is beneficial to consumers generally, because it provides them with a spectrum of options that they would otherwise not be privy to. Choice in a free-market system is good for consumers.

Additionally, there are services that are directly provided to consumers which a veto of SB 362 would preserve: anti-fraud and identity verification services, marketing services, loyalty programs, cybersecurity and others.

If enacted, SB 362 would require all data brokers to delete data upon request, hampering small businesses' ability to remain competitive and profitable. Currently, the CCPA already provides a deletion right that compels businesses to honor deletion requests and requires down-stream deletion flow as well. SB 362 would therefore enact contradictory and duplicative standards which can only cause confusion among consumers and businesses alike.

NFIB therefore respectfully requests a veto of SB 362 (Becker).

Governor Newsom,

On behalf of the California Hispanic Chambers of Commerce and the 850,000 Hispanic-owned businesses we represent, I respectfully request your veto on SB 362.

This legislation will allow the abrupt deletion of consumer data that is currently used by countless California small businesses - more than a quarter of which are minority-owned and operated - to effectively engage with prospective customers in an affordable way. This will put small businesses at a severe disadvantage compared to larger companies with much bigger advertising and marketing budgets, including competitors from out of state.

Not only will SB 362 create an uneven playing field for Hispanic and diverse businesses, but it is also completely unnecessary. The California Consumer Privacy Act, which Californians approved by ballot initiative three years ago, already allows consumers to request that businesses delete their personal data. There is no justification for taxpayer dollars to be spent on a redundant system that is going to cost upwards of tens of millions per year to create and maintain.

SB 362 also stands to undermine safeguards against consumer fraud. For example, businesses and government entities rely on third-party consumer data to verify people's identities, which helps protect them against fraudulent activities and scammers. If this data is permanently deleted, it makes identity verification much more difficult, opening the door to identity theft and a range of other fraud. This will disproportionately harm minority consumers who may not have access to financial services and must rely on other types of data sets to be authenticated - data sets that would be deleted under SB 362.

For these reasons, I request a veto on SB 362. This bill was clearly rushed through the legislative process, and it should be held so that, for the sake of minority small businesses and consumers, these serious issues can be solved before moving forward.

On behalf of the California Black Chamber of Commerce and the hundreds of small and emerging businesses, affiliates, and chambers of commerce throughout the state that we represent, I urge you to veto Senate Bill 362 (Becker).

Dear Governor Newsom:

On behalf of the Family Business Association of California (FBA), we ask for you to veto SB 362 (Becker). FBA is a nonprofit 501(c)(6) organization that is the only association in California that solely focuses on representing family businesses at the state Capitol. We take a stand against harmful legislation, and fight for bills that are good for family businesses.

SB 362 will have unintended consequences that will be detrimental to family-owned businesses, which make up 1.4 million businesses in the state and employ about 7 million Californians.

FBA members rely on access to reliable consumer data to find and reach potential new customers, Unfortunately, SB 362 would allow this consumer data to be wiped away, limiting family-run businesses' ability to reach new customers.

The potential for increased fraud posed by SB 362 is also troubling. Much of the data that would be impacted by the mass deletion called for in the bill is used in anti-fraud efforts and for identity verification services, both important consumer protections. It would also wipe out data used in consumer loyalty programs and many other services that benefit consumers.

For these reasons, the Family Business Association of California asks you to veto the bill to allow additional time to work through these concerns.

The Inland Empire Economic Partnership (IEEP) is the largest and most prominent organization serving small, medium and large-scale businesses and employers, and industries, across the Riverside, San Bernardino and entire Inland Empire region. Our members strive every day to create jobs, support their communities and help boost the local Southern California and Golden State economies.

We are asking you to please consider lending a VETO to SB 362, the Delete Act, which, while perhaps well intended, would have devastating consequences for job creators and all California communities. Businesses, especially small and ethnic businesses, in this post-pandemic economy, are struggling to keep their doors open, people employed and customers "coming through the doors". They rely on reliable, legitimate data sources about consumer habits, trends and desires to help them best serve their customers. If SB 362 becomes law, it will make it nearly impossible for these employers to compete with other, more sophisticated industries and employers that can easily and readily access this information.

Moreover, SB 362 is likely to open the door to much consumer fraud, again not an intent of the author but something that is inevitable. There is no requirement in SB 362 to determine if it is truly the consumer or authorized agent making the deletion request. Consumers that don't have access to financial services must rely on other types of data sets to be authenticated, and businesses and government entities must rely on these non-exempt data sources. This will primarily hurt minority customers. This type of fraud use data would be deleted under SB 362 and primarily impact minority consumers who would have difficulty obtaining financial and other consumer services.

Please keep our leading job creators, small and ethnic businesses, and all industry and communities - as well as consumers -protected and supported. We need to create a pathway, not roadblocks to economic and job growth and recovery in California. Please VETO SB 362. Thank you.
